

We welcome the Fiscal Year 2018-2019 with confidence and pride as we remember the achievements and lessons brought by last fiscal year's activities. We now move towards the continued implementation of relevant programs for the benefit of TVET stakeholders in the region.

We are elated to report that the Philippines, through the efforts of the Technical Education Skills Development Authority, has continuously tapped CPSC to be the training provider the theme about greening TVET for sustainable development. Implemented in three batches from May until August, it involved a total of 114 TVET school administrators, experts and provincial officers from all over the country. IN-COUNTRY TRAINING PROGRAM ON

Greening TVET for Sustainable Development Invites Second Batch of TESDA School Administrators

Continuing the success of the first program held on May 21-25, 2018, the second In-Country Training Program on Greening TVET for Sustainable Development was organized from July 16 to 20, 2018 at the National TVET Trainers Academy (NTTA) in Marikina City, Philippines. This program tapped the participation of 42 administrators TVET institutions and provincial training centers under the jurisdiction of the Technical Education and Skills Development Authority (TESDA).

The five-day event was jointly organized by CPSC led by its Director General, Dr. Ramhari Lamichhane, and TESDA, led by the Director General, Sec. Guiling Mamondiong. Program resources were furnished by CPSC's Faculty Consultant, Dr. Chithral Ambawatte. Local logistics was facilitated by the Director of the National Institute for Technical Education and Skills Development (NITESD), Mr. Elmer K. Talavera. Additional resources meanwhile were provided by the Visiting Faculty Consultant, Dr. Romulita Alto and the Faculty Specialist, Ms. Therese Lee.

As with the first batch, a Panel Discussion on "Transforming TVET for Sustainable Development" was organized on July 19, 2018 to further supplement the lessons of the program with

Third Batch of Filipino TVET Professionals Trained by CPSC on Greening TVET for Sustainable Development

As the Philippines and the entire Asia-Pacific region is seen to be in the receiving end of the repercussions of climate change, there is a need to put forward some initiatives to create awareness and provide knowledge on the greening process among the administration, faculty, trainers, and students.

It is the motivation in holding the third batch of the in-country program on Greening TVET for sustainable development. It was held at the National TVET Trainers Academy (NTTA) in Marikina City from July 30 to August 3, 2018. A total of 37 participants from Eastern Visayas, Zamboanga Peninsula, Northern Mindanao, Davao Region, SOCCSKSARGEN, Caraga Region, and Autonomous Region in Muslim Mindanao (ARMM) were invited to participate in this session.

In addition to the classroom discussions, study visits to some of the notable sites where green TVET is practiced are also included. The participants were able to visit the Manila Water Company, UP Diliman Task Force on Solid Waste Management and the Quezon City Biogas Emissions Reduction Facility.

These visits are meant to show to the participants the actual practices of environmental conservation technologies.

Quality Assurance System through Results-Based Monitoring and Evaluation-Focus of this Year's In-Country Program in Fiji

The Colombo Plan Staff College, in cooperation with the Ministry of Education, Heritage and Arts (MEHA), successfully conducted the In-Country Program on Quality Assurance System through Results-Based Monitoring and Evaluation Management Systems for TVET Institutions and Educational System at the Regional Training Centre – Revenue and Customs Complex in Suva, Fiji from September 24-28, 2018. The program was able to tap the participation of 25 staff members from the Technical College of Fiji (TCF) and MEHA-Technology and Employment Skills Training (TEST), as well as heads of government schools around the country.

The in-country program dealt with a discussion and analysis of quality assurance in an educational system through the use of results-based monitoring and evaluation. This approach was adopted to determine the relevance and fulfillment of objectives, development efficiency, effectiveness, impact, and sustainability.

The program was coordinated by Ms. Therese Tan Lee (CPSC Faculty Specialist) and was supervised by Dr. Ramhari Lamichhane (CPSC Director General) and Ms. Alison Burchell (Permanent Secretary of the Ministry of Education, Heritage, and Arts). Local arrangements were facilitated by Ms. Rina Roshni Chand (Senior Education Officer,

n his capacity as the Director General of CPSC, Dr. Ramhari Lamichhane presented a paper on the role of professional bodies ushering TVET for the Industrial Revolution 4.0 at the 2018 Asia TVET Experts Forum (ATEF) held from July 23-24, 2018 at the Everly Hotel in Putrajaya, Malaysia.

The event was organized with the theme, "Embracing TVET for Industrial Revolution" which aimed to discuss perspectives of various TVET providers and institutions on how to address the impact of the 4th industrial revolution. Participated by 57 experts coming from countries such as Malaysia, Philippines, Bangladesh, Indonesia, Singapore, Brunei, Vietnam, this forum was organized by Universiti Tunn Hussein Onn Malaysia (UTHM), within the purview of the Ministry of Education Malaysia, and in partnership with the Asia TVET Experts Network (ATEN). Lessons learned in this event will be carried over to the next ATEF Meeting tentatively scheduled in May 2019 at Ningbo Polytechnic in Ningbo, China.

After the event, the Director General was also able to meet the officials of the Department of Polytechnic and Community College Education (DPCCE), Ministry of Education, Malaysia to discuss future activities for cooperation such as the planned in-country programs in Malaysia, future APACC onsite visits and other important matters.

CPSC Director General Attends the International Seminar on Global Competitive TVET for Challenges of Industrial Revolution 4.0 in Dhaka, Bangladesh

he CPSC Director General, Dr. Ramhari Lamichhane, and former CPSC Seconded Faculty, Dr. G. Kulanthaivel, were in Dhaka, Bangladesh from September 15 to 17, 2018 as presenters and guests of the International Seminar, Round Table and Policy Dialogue on "Global Competitive TVET for challenges of Industrial Revolution 4.0, Innovative professionalism & skills for achieving sustainable development goals (SDGs)-pathways of 4.0 Industrial Revolution".

Organized by the Institute of Diploma Engineers, Bangladesh (IDEB), the international seminar aims to hold an open policy dialogue in order to understand how Bangladesh can respond to and prepare for facing challenge of the 4th Industrial Revolution. It was a combination of presentations, panel discussions, and small group discussions, structured to allow participants to openly share knowledge, opportunities, challenges and education strategies.

The two-day international seminar was attended by almost 10,000 participants from 10 countries. It was formally opened by H.E. Prime Minister Sheikh Hasina of the People's Republic of Bangladesh at a ceremony held on September 15, 2018.

The discussions were based on overarching themes: the characteristics of the 4th Industrial Revolution, challenges

of 4th IR, way of skilling up the peoples through TVET incorporating 4thm IR and way out for sustaining in global competitive job market. Given these themes, Dr. Lamichhane prepared and presented a paper that further discusses the role of TVET in the 4th industrial revolution.

CPSC was also able to promote its services to the stakeholders of IDEB as it also anticipates more vigorous engagements with the organization in the future. A joint regional program and international seminars were envisioned to be arranged in the coming months as both organizations strengthen their ties to each other. The CPSC Director General was also able to meet some of the key officials of the Government of Bangladesh and the IDEB, as well as other representatives of international offices based in the country, as a testament of this affirmation.

The Don Bosco Philippines-One TVET System, a network of technical schools that mostly benefit marginalized, out-of-school youths in the Philippines, sent 20 of their Directors to CPSC's headquarters in Manila, Philippines for a two-day training on Enhancement of TVET Leadership and Management on July 18-19, 2018. The program was realized for the benefit of the participating technical schools to manage a "change capable culture" that enhances their ability to sustainably adapt to the changing landscapes of TVET education.

The following topics were tackled during the training: (1) Educational Transformation through Leadership in TVET Institutions; (2) Leadership through Effective Communication and Communication Strategies in a Diverse Workplace Environment; (3) Managing Change and Improving Adaptability Through Organizational Development in the 21st Century; (4) Managing Employees from different Generations and Developing Employees to Become Future Leaders; (5) How the Leadership and Management Dynamics Contribute to TVET Institutions' Effectiveness and (6) Excellence of Leadership for Change Management through PDCA Cycle in TVET Institutes.

The program was facilitated by Ms. Therese Tan-Lee, CPSC Faculty Specialist as Program Coordinator. Dr. Romulita C. Alto, former CPSC Faculty Consultant, delivered a paper presentation and contributed to the learning experience of the participants. The program was under the helm of

CPSC SUCCESSFULLY TRAINED TVET ADMINISTRATORS ON PROJECT MANAGEMENT TECHNIQUES IN TVET

The Colombo Plan Staff College, through its open registration programs that are readily available in its website, successfully trained 16 TVET administrators, government officials and project managers from various TVET learning institutions and government ministries in the Philippines, Thailand, Singapore, Bangladesh and Nepal on project management processes and techniques. This was made possible during the 5-Day Customized Program on Results-Based Project Management in TVET Institutions held from September 17-21, 2018 at CPSC's Headquarters in Manila.

The program was organized to enable the participants to learn the dynamics, definitions and processes in project management and understand project planning, project implementation and project evaluation as key phases in project management. They were also asked to demonstrate their knowledge in project planning by preparing project problem tree analysis, objective and solution. They also designed the project proposal using the project log framework matrix and applied project management tools and methodologies for managing TVET programs and projects.

In addition to the classroom lectures, the program also included study visits to the Development Academy of the Philippines and College of Public Affairs in Los Baños, Laguna in which they were oriented with some of the best practices in institutional administration and project management.

The program was supervised by the CPSC Director General, Dr. Ramhari Lamichhane and coordinated by the CPSC Faculty Specialist, Ms. Therese Lee. Academic resources were provided by the CPSC Faculty Consultant, Dr. Chithral Ambawatte and the Research, Publications and Information Officer, Mr. Rae Emmanuel Echaveria.

QUALITY MANAGEMENT SYSTEMS TRAINING FOR TESDA PERSONNEL FROM VARIOUS REGIONS OF THE PHILIPPINES

Colombo Plan Staff College The conducted the Customized Training Program on Enhancing Quality Management System (QMS) towards Quality Assured TVET Delivery and Service for the 54 personnel coming from the Technical Education and Skills Development Authority (TESDA) Institutes from the 15 regions of the country, TESDA Central Office and other satellite offices. The training was held from September 24-28, 2018 at the BSA Twin Towers in Ortigas, Manila.

The five-day knowledge transfer exercise was organized to further educate the participants on the concepts and principles of QMS, help them identify the applications of Plan-Do-Check-Act (PDCA), QMS Principles, and Tools for TVET institutions. The program helped the participants understand the APACC and STAR accreditation systems and other such quality assurance certifications for QMS. The program culminated with the participants preparing a Monitoring and Evaluation Plan in implementing QMS for TVET institutions in view of continual improvement.

The program was coordinated by CPSC Faculty Consultant, Dr. Chithral Ambawatte under the supervision of the Director General of CPSC, Dr. Ramhari Lamichhane. Additional resources for academics were provided by Dr. Romulita Alto, Research Consultant at the Technological Institute of the Philippines and Project-Based Faculty Consultant of CPSC, and Ms. Janet Abasolo, the Division Chief of the Program Registration Division in the Technical Education and Skills Development Authority of the Philippines.

Bangladesh Education Ministry Secretary, Key TVET Officials Affirm Ties with CPSC

Thirteen (13) officials from various government agencies and projects of the Bangladesh Education system were in Manila for a 5-day learning visit and exposure on the implementation of the Philippine Qualification Framework (PQF). They were composed of proposed members of the National Steering Committee of the Bangladesh Qualification Framework (BQF) and leaders of National Quality Assurance and Accreditation System (NQAAS) and they visited the Philippines from July 22-27, 2018 and Malaysia from July 28- August 2, 2018.

Notable officials in the delegation include the Secretary of the Technical and Madrasah Education Division (TMED) of the Bangladesh Ministry of Education, Mr. Md. Alamgir and the Director General of the Directorate of Technical Education, Mr. Ashoke Kumar Biswas. In their capacity, they were able to facilitate CPSC's numerous engagements in Bangladesh through the years.

The delegation was officially received by the CPSC team led by its Director General, Dr. Ramhari Lamichhane through a program held on July 27, 2018. During their visit, they were also able to understand CPSC's role in the development and implementation of qualification frameworks in the Philippines and CPSC member states. They were also able to learn about the steps that TVET and education institutions undertake with regard to institutional self-assessment and other related activities through a brief presentation about the Asia-Pacific Accreditation and Certification Commission (APACC). In addition, they also visited the National Coordinating Council of the Philippine Qualification System (PQF), Lyceum University, Commission of Higher Education (CHED) Philippines and the Technical and Skills Development Authority (TESDA).



CPSC and APACC Participate in PQF IRR Public Consultation

Through the invitation of the Philippine Qualifications Framework (PQF) Coordinating Committee, the Colombo Plan Staff College (CPSC) and the Asia Pacific Accreditation and Certification Commission (APACC) represented by the APACC Officer Ms. Adrienne Abril, participated in the "PQF Act Implementing Rules and Regulations (IRR) Public Consultation for National Capital Region (NCR)" on September 21, 2018. The consultation was held at the Bayanihan Center, United Laboratories, Inc., Pasig City, Philippines.

CPSC/APACC provided inputs and comments on the draft IRR and informed of the availability of information contained in CPSC publications on Asia Pacific countries' Qualifications Framework, in case PQF Coordinating Committee requires it for comparison purposes. This activity, which is the last leg of the consultations, served as a venue for soliciting comments and ideas from officials from NCR to achieve an effective IRR.

The Department of Education Honorable Secretary Leonor Magtolis Briones, who is also the Chairperson of the PQF National Coordinating Committee, closed the event through a Special Remarks.

In his opening speech, Engr. motivated Manqui RNIT faculty and staff to "regain the lost glory" of the institution and gear it up to international expectations subjecting through their processes to the audit and scrutiny of APACC. response, the APACC Team Leader, Ms. Lee, reaffirmed APACC's commitment assist in the development of VET institutions in the region through the implementation of quality assurance process in its systems and operations.

It was created under the provisions of the Republic Act 4581 which was approved on June 19, 1965. On May 23, 2016, the Republic Act 108491 was enforced, changing its former name to the present.




PUO, Malaysia Continues Quality First APACC On-

Malaysia started subscribing to the Asia Pacific Accreditation and Certification Commission (APACC) in 2014, with 3 premier polytechnics given the distinction of being the first institutions to be visited and received APACC Gold Award in the country. One of these polytechnics, the Politeknik Ungku Omar (PUO) located at Ipoh, Perak, Malaysia, subjected itself to APACC reaccreditation on July 30 to August 1, 2018, 4 years after the first visit. To assess the improvements based on recommendations from the first visit and to generally evaluate the overall compliance of PUO to the APACC standards, an international team composed of Dr. Paiboon Saiyawongs, APACC Special Officer in Thailand, Dr. Rajendra P. Adhikari, Advisor and Former President of Diploma Engineers Association of Nepal, and Ms. Adrienne Abril, APACC Officer, was assigned.

PUO was established in 1969 named after Professor Dato' (Dr.) Ungku Omar bin Ahmad, the first Malay Director of the Medical Research Centre. One of the polytechnic's niche area is Marine Engineering and the Marine Engineering Department was recognized as the Best Maritime Institution in 2016.

The activity was inaugurated by the welcoming remarks of PUO Director Tn. Haji Zairon bin Mustapha. According to him, PUO has continually improved after the first APACC visit by addressing the recommendations, maintaining good practices, and sometimes exceeding what are expected. New buildings and facilities, interactive classrooms, and industry-sponsored education center are among the additional facilities being enjoyed by staff and students alike. He mentioned that through APACC, PUO was able to respond to changes effectively.

The Colombo Plan Staff College is pleased to welcome the new batch of professional interns under the Professional Internship Program for International Experience (PIPIE).






